# **Garmin Fishing Online Regulations – 2025**

- 1. **Organizers** KURNIK FISHING TOMASZ KURNIK, ul. G. Zapolskiej 37A/4, 41-807 Zabrze, NIP 648 222 79 39
- 2. Hosting the event Garmin Fishing
- 3. **Studio** from the studio level the entire event will be available live, along with a system of connections with participants. The studio will be available on the Garmin Fishing Online Facebook channel.
- 4. Events dates
  - 17.05 2025
  - 19.07.2025
  - 20.09.2025
  - 18.10.2025
- 5. Presenters: Tomasz Kurnik, Tomasz Górski, Olin Gutowski.
- 6. Participation rules and regulations:
- **Refereeing** assessment and control over the correct process of the event/ competition using the 'SmartFish' referee application.
- **Place** any body of water chosen by the event/competition participant it may be a river, lake, dam reservoir, or even sea water. Excluding commercial waters. The selected body of water cannot be changed during the round. The selected fishing spot should be reported in the registration form (item 'selected fishing spot', polish: 'wybrane łowisko')
- **Messages** and information about the competition will appear on our Facebook page Garmin Fishing Online
- Participation and the right to start every willing angler who registers for the competition, pays the entry fee and fills out the application form will have the right to start.
- Competitors bear the costs of permits for the water areas they choose.
- Competitors start individually.
- Fishing methods spinning, trolling and fly fishing methods are allowed.
- Fishing from the shore and from vessels operating in Poland or abroad is allowed.
- All participants fish in accordance with the rules of the Polish Angling Sport Organization, and outside our country, additionally in accordance with the internal regulations in force on a given reservoir.
- Competitors under 18 years of age may fish only under the supervision of an adult guardian who also takes part in the competition, after completing the appropriate form. To obtain a form for a minor, please contact us by e-mail at <a href="mailto:info@smartfish.online">info@smartfish.online</a>
- During the event, the judging panel may ask selected participants to send the 'pins' on the Google map from the place where it is currently located from the registered number on our website.
- Participants must strictly follow all recommendations and rules related to maintaining safety introduced during the **Covid-19** pandemic.
- Each participant takes part in the competition at his or her own risk.
- The organizer is not responsible for failure to comply with the regulations in force in the area where the participant is located.
- The competition round lasts from **09.00** to **17.00** (GMT + 01:00).
- **Before starting the round**, competitors receive a **special code** via the application, which they **must show** in each photo with a fish. Each competitor must have a piece of paper and a marker to write the code on it.
- 7. Prizes material prizes with a market value of PLN 30,000
- will be sent to the addresses indicated in the form that will be valid when registering the competitor for the Garmin Fishing Online competition. Prizes will be sent only to addresses in Poland.
- The winners are obliged to provide the competition organizer, within 2 weeks from the end of the competition, with full details for shipping the prizes along with the selected size of Graff clothing. Full details should include the address for shipping prizes in Poland, name and surname and Polish telephone number of the recipient of the shipment. If the winner does not send complete data by the

deadline, he will have the chance to complete the data and the prize will be sent after the next edition of GFO (does not apply to the last edition of the year).

- On the day the competition starts, an encrypted file will be sent to the competitors via the application. The file will contain the so-called **tournament clock**. The clock will include:
- exact hours selected by the Organizers. The competitor who catches a fish closest to the time specified by the Organizers wins the prize assigned to it. In case of a draw, the longer fish wins. One competitor can only win one prize from the tournament clock. After the first hit on the clock, the competitor does not participate in further hits.
- Due to the form of the competition and the inability to control the competitors, places from I to III will be awarded only with Garmin Fishing Online statuettes.
- The formula of our event is very open, so the most valuable prizes will concern competitions, which the competitors will be informed about during the round via messages sent through the application.
- Prizes will be sent only to addresses in Poland.
- Shipping will take place within 30 days.

#### 8. Fish species that will take part in the competitions and will be assessed by the judges:

- Every cm started on the measure is considered as passed, i.e. a pike rated at 50.1 cm will be counted as 51 points, a pike rated at 50.0 cm will be counted as 50 points.
- 1 cm is 1 point.
- All dimensional fish reported during the round will be taken into account for the tournament clock.
- 15 longest fish will be included in the general score
- Ide size 30cm
- Asp size 50cm
- Chub size 30cm
- Perch size 23cm
- Pike size 50cm
- Trout size 33cm
- Zander size 50cm (does not take part in the May edition of the competition)
- Catfish size 80cm (does not take part in the May edition of the competition)
- Barbell size 50cm (does not take part in the May edition of the competition)

## 9. Refereeing using the mobile application:

- The correct course of the competition will be supervised by judges responsible for technical matters and the main referee of the competition, Tomasz Kurnik.
- The application works with IOS and Android.
- Each competitor must have a smartphone with the ability to take photos and access to the Internet.
- Each competitor is obliged to download and install the application.

# 10. Rules for reporting caught fish:

- We report caught fish by taking a photo using the application.
- A fish caught twice in the same day will only be counted once.
- The competition takes place on "living fish" and is reported using the referee application.
- It is forbidden to keep fish in lockers or nets longer than required by the application.
- Killing or abusing fish will result in disqualification from the competition.
- Photos of fish on measuring cups are taken horizontally, placing the fish with its right side against the measuring cup, so that the fish's mouth touches the beginning of the measuring cup.
- The photo must include the entire fish and must show the code that will be provided before the start of the competition.
- During the competition, participants will use their own measuring cups to measure fish.
- Photos showing a bloody fish are poorly visible, the measurement of the fish is illegible, the fish is measured on the wrong side and its lips do not touch the beginning of the measurement, photos in which the code is invisible or illegible will not be counted.
- Any complaints may only concern the photo sent via the application. Competitors are responsible for taking the photo correctly. Other photos will not be taken into account when awarding points.

• In case of problems with the application or sending a photo of the caught fish, the competitors are obliged to immediately report this to the Chief Judge or the Measuring Judge, who will decide how to solve the situation, including the possibility of counting the fish based on the photo taken without the application, however, with all other requirements for reporting the fish caught. If the above problems are not reported to the judge, the fish will not be counted.

## 11. Registration:

- Applications to GARMIN Fishing Online will be accepted via the website www.smartfish.online. After entering the website, register and enter the selected fishing spot in the "favorite fishing spot" position, and then make a transfer.
- After making the transfer, the competitor will be placed on the starting list.
- Online applications will be accepted until 24:00 the day before each edition of the competition. The number of participants is limited. The date of transfer of entry fee is decisive.

### 12. Entry fee:

- in the amount of **PLN 165** per participant from the age of 15
- children up to 15 years of age free of charge, as long as they start with an adult.
- All costs of paying the entry fee are covered by the person making the payment.
- During registration, you can pay by traditional transfer to the account: **21 1050 1331 1000 0092 5074 9877**
- The transfer title should include: "name and surname, Garmin Fishing Online entry fee, date of the selected edition and telephone number"
- The organizer issues electronic VAT invoices if the participant previously submits a request for an invoice along with company details sent to <a href="mailto:info@smartfish.online">info@smartfish.online</a>
- If a participant resigns from participating in the event for reasons beyond the organizer's control, the organizer is not obliged to return the entry fee.
- The entry fee is collected from participants to cover the costs of organizing Garmin Fishing Online.
- If, for reasons beyond the organizer's control, the event cannot be held on the scheduled date, the entry fees will not be refunded, but the organizer will set another date for the event.

#### 13. Announcement of results:

• The results of all competitions and the official ranking of participants in each edition will be announced after the end of the competition at 8:30 p.m. (GMT + 01:00) during a live broadcast on FB - Garmin Fishing Online.

## 14. Personal data protection:

Personal data provided by Participants are protected as personal data within the meaning of the provisions of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing the directive 95/46/EC (hereinafter GDPR).

The administrator of personal data is KURNIK FISHING – TOMASZ KURNIK

The purpose of personal data processing is to carry out all activities necessary for participation in the competition, the Administrator's provision of services related to the organization and participation of Participants in the competition, publication of results, starting lists, handling complaints, pursuing claims, and fulfillment of tax obligations.

The legal basis for processing is that processing is necessary for the performance of a contract to which the data subject is a party or to take action at the request of the data subject before concluding the contract (Article 6(1)(b) of the GDPR) and to fulfill the legal obligation imposed on the Administrator (Article 6(1)(c) of the GDPR).

Personal data may be disclosed by the Administrator to entities cooperating with him in the provision of services, on the basis of data processing contracts, in accordance with applicable legal provisions

regarding the protection of personal data (in particular to the competition organizer, if it is an entity other than the Administrator, IT service providers, results measurement, printing, etc.).

In connection with the processing of personal data, the Participant has the following rights:

- the right to withdraw consent to data processing in such a case, however, the Administrator informs that it will be impossible for the Administrator to fulfill the obligations of the event organizer, in particular enabling the Participant to take part in the competition, measuring results or issuing a prize;
- the right to access personal data and the right to request its rectification, deletion or limitation of its processing;
- the right to object to processing;
- the right to transfer data in accordance with the principles set out in the GDPR;
- the right to complain to the supervisory authority.

Personal data will be processed throughout the entire period of organization and course of the competition, and also after that time if it is necessary to perform the obligations provided for by law or pursue the interests of the Administrator.

The participant consents to the recording of his/her image during the competition using any technique and consents to the Administrator's free use of such a recorded image solely for information, promotional and marketing purposes related to the competition. This consent covers the use of the image in all fields of exploitation referred to in Art. 50 of the Act on Copyright and Related Rights. The user consents to the processing of the image by cropping, digital processing, composition, combining with other images or images of other people to the extent necessary for the purposes described above.
